The Director of Horticulture & Secretary, OHDS invites Expression of Interest in sealed cover from intending Public Sector Undertakings/Public/ Private Entrepreneurs/Agencies engaged in producing different Quality Planting Materials intending to supply the same to the farmers of Odisha under Govt. programme for the year 2019-20. The sealed Expression of Interest should be submitted to this Directorate on or before 21.06.19 by 5.00P.M. by Registered/ Speed Post (P&T Deptt.) only. The Technical Bid will be opened on 22.06.19 at 11.00 A.M. and the Financial Bid will be opened on 25.06.19 at 11.00 P.M. in the Conference Hall of this Krushi Bhawan. The sealed envelope should be super scribed with **“EOI for Empanelment of producers/suppliers of QPM for supply during 2019-20”** The detail including terms and conditions of the Expression of Interest is available in the website.

TERMS OF REFERENCE

1. During the year 2019-20 Directorate of Horticulture have plantation programme of different fruit / medicinal crops for which the Quality Planting Materials as mentioned in the Annexure below may be required by the farmers. The quantity of seeds or seedlings mentioned below is tentative and may increase or decrease as per actual requirement.

- * The source point of pineapple suckers is either from West Bengal (Siliguri) or inside Odisha.
2. The last date for submission of the Expression of Interest (EOI) is on **21.06.19** at 5.00 P.M and the technical bid will be opened on **22.06.19** at 11.00 A.M in the Board Room of the Krushi Bhawan. The financial bid will be opened on **25.06.19** at 11.00A.M. at the same venue.
 3. The EOI will be valid up to 31st March, 2020
 4. The bidder or authorized representative shall be present at the time of opening of the EOI.
 5. In case of absence of the bidders or their representative the Committee has the right to open the EOI.
 6. **Only the Producer / suppliers of Quality Planting Materials (mentioned in the Annexure) shall take part in the process.**
 7. The Producer of Tissue Culture plantlets has to furnish valid copy of **Accreditation with DBT Certificate along with Technical Bid.**

8. The Financial offer should be FOR farmers point.
9. The rate offered and approved by the State Level Seed Pricing Committee shall be valid till 31.03.2020.
10. The Producer/Supplier has its own responsibility to sale the QPMs to farmer at approved rate. The supplier has also to furnish valid receipt to farmer in support of sale.
11. Quality of the Planting Material is the sole responsibility of the producer / supplier.
12. The technical parameters of the Quality Planting Materials (as per **Annexure I**) should be adhered to.
13. Any dispute arising regarding Quality of planting material in the field will be verified through scientists from OUAT/ KVK/ CTCRI/ CHES/RRTTS / Dept. officials or Team as constituted by Director of Horticulture, Odisha.
14. There should not be any precondition of advance payment or time limit, what so ever. Any bid submitted will be taken as absolute without any precondition.
15. In case of procurement by Government agencies, procurement should be from the L1 producer out of the empanelled producers. However, if there is sufficient reason or ground, the District Level Purchase Committee headed by Collector will be competent to finalize a specific product from among the empanelled producers at the offered price and not opt for L1 producer and necessary justification should be recorded in the minutes of the meeting of the committee.
16. The Quality Planting Materials (as mentioned in the Annexure) will be sold to the farmers by the bidder. Government is proposing to provide subsidy to the farmers who cultivate by procuring from the empanelled suppliers on crop coverage basis.
17. Supplier will be empanelled for sale throughout the State.
18. The source verification i.e. Quality Planting Materials, production requirement, mother plant, production capacity, technical manpower etc. shall be verified by the expert team constituted by Director of Horticulture.
19. Supply of seeds of Medicinal plants is subject to satisfactory germination test.
20. The QPMs will also be verified after arrival at Sub-Divisional level before delivery to the farmers.
21. The cost of verification at all level and cost of other testing if required will be borne by the supplying agency.
22. The Director of Horticulture & Secretary, OHDS reserves the right to reject the bid quoted by any organization / agency, if not satisfied with concerned organization / agency's credibility and past experience. Further the Director of Horticulture & Secretary, OHDS also reserves the right to accept/ reject/ modify any or all clauses of EOI without assigning any reason thereof.
23. EMD for different planting materials per producer /supplier (as in pt. No. 1 of TOR) should be attached with EOI in shape of Bank Draft payable to Director of Horticulture and Secretary, OHDS, Bhubaneswar in any nationalized bank situated at Bhubaneswar along with technical bid. MSME unit holders are exempted from EMD.
24. The EMD will be forfeited in case the bidder disagrees for supply / source verification of the planting materials after selected in the empanelment process.

25. The bidder shall fill up the Financial Bid as well as Technical bid and submit in separate sealed cover along with necessary documents. The Technical Bid & **crop wise separate Financial Bids** should be put in separate envelope and super scribed as Technical Bid / Financial Bid indicating the crop as the case may be. Both technical and financial bids should also be put inside another sealed envelope and super scribed with “**EOI for empanelment of producers / suppliers for supply of Quality Planting Materials of fruits / medicinal crops” for 2019-20**”. The same should be sent through P & T Department by Registered Post / Speed Post only to the Office of the Director of Horticulture, Odisha, Krushi Bhawan, Gopabandhu marg, Keshari Nagar, Bhubaneswar-01 without any precondition and should have to reach before the date & time fixed for this purpose.
26. The technical bids will be evaluated by a committee constituted for the purpose and the findings of the committee will be final and binding. The same cannot be challenged at any forum thereafter. Intending bidder will have to submit undertaking in this regard.
27. No communication shall be entertained over Telephone, FAX, E-mail or in person.
28. The supplier shall abide by the stipulated date for sale of those Quality Planting Materials to the farmers fixed by the ADH / DDH / Director of Horticulture & Secretary, OHDS.
29. An undertaking in a Rs.10/- Non-Judicial stamp paper stating the following has to be attached with the technical bid:
 - a. The decision of the evaluation committee will be final and binding.
 - b. I (Name and address of the Producer Company / Supplying Agency) will be responsible for quality of the planting materials.
 - c. If the planting Materials quality is found to be defective or poor, I (Name and address of the Producer Company / Supplying Agency) will refund the cost of planting materials and pay compensation as decided by the technical committee constituted for this purpose.
 - d. I agree to supply planting materials to the famers of the State at the offered price irrespective of the places.
 - e. The EMD will be forfeited, if I will fail to supply / disagree for source verification after selected for empanelment
30. **One producer/ supplier will submit one bid for each crop.**
31. The interested agencies may download the EOI documents including format of Technical Bid and Financial Bid from the department website www.odihort.nic.in and also from www.odisha.gov.in.
32. Any legal dispute shall be finalized in Bhubaneswar Jurisdiction only.
33. Any complicity arises above these points of the ToR will be settled mutually.
34. Empanelment of producer farm / NHB accredited nursery / Tissue culture laboratory/ supplier does not necessarily guaranty upon procurement of planting materials by the department.
